Texas REALTORS® Relief Fund Application

The Texas Association of REALTORS® has set up a relief fund for persons who have suffered losses due to natural disasters in Texas. This application is for Texas residents who have suffered property damage to their primary residence as a result of the severe weather and flooding event which began June 18, 2018. Relief assistance is limited to a maximum of \$1,000 per applicant, and is restricted to those located within the jurisdiction of a participating local REALTOR® association and counties for which the governor has declared a state of disaster. - **You must include proof of residency (e.g., a copy of your driver's license or other government documentation evidencing residency) with this application.**
- **You must provide proof to support your answers.** The following are examples of documents that may be used to support your claim:
 - Photographs of damage to property structure of primary residence (no more than 5 photographs, please)
 - Copies of repair estimates from contractors
 - Copies of written claims, settlement proceeds, or claim status reports
 - Copies of hotel/motel receipts
 - Copy of your current mortgage statement or other documentation that provides proof of monthly mortgage payment amounts (if you own) or copy of your current lease or other documentation that provides proof of monthly rental and security deposit amounts (if you rent)
 - Copy of new lease or other documentation, which provides proof of monthly rental and security deposit amounts

Applicants who do not respond to each question and who do not provide the required supporting documentation will not be considered.
