The undersigned persons desiring access to the Multiple Listing Service (MLS) operated by the Texas REALTORS® acknowledge and agree to the following:

- (1) We have read the Rules and Regulations governing the MLS.
(2) We agree to comply with the Rules and Regulations as they may be amended from time to time.
(3) We understand that Texas REALTORS® will attempt to, but is not obligated to, give us notice if the Rules and Regulations are amended from time and that we can access a current copy of the Rules and Regulations either on the MLS web site, TEXAS REALTORS's web site, or by requesting a copy from Texas REALTORS®.
(4) We agree to pay all fees, in advance, for access and use of the MLS. We understand that those fees may change from time to time without advance notice. As of the date this agreement is signed the fees for access to the MLS are as shown on the attached Fee Exhibit.
(5) We understand that we may be required to agree to a license agreement with the vendor who provides the software and programs to Texas REALTORS® for use with its MLS. We represent that we will comply with the terms of any such agreement when accessing the MLS.
(6) We understand that the resolution of any dispute is governed by the Rules and Regulations.
(7) As the undersigned Participant, I am responsible for the actions of all Subscribers who are affiliated with me. I will take necessary steps so that Subscribers affiliated with me will comply with the Rules and Regulations. I will be responsible to TEXAS REALTORS for the payment of all fees, charges, and fines assessed against me and the Subscribers affiliated with me.
(8) We will not permit anyone who is not a Participant or Subscriber to access or use the MLS or the MLS information, except as permitted by the Rules and Regulations.
(9) If any of the undersigned Subscribers cease to be affiliated with the Participant as employees or independent contractors, the Participant and Subscriber will promptly notify Texas REALTORS®. We understand that a Subscriber may not access or use the MLS independently of a Participant.
(10) All fees, once paid, are not prorated and are not refundable.

**Fee Exhibit
to Application for access to the
Texas Association of REALTORS® Multiple Listing Service**

All fees for access to and use of the MLS must be paid in advance.
Fees for access to and use of the MLS may change from time to time without advance notice.
As of the date this agreement is signed the fees for access to and use of the MLS are as follows

(1) Initial Participation Fee.

An applicant for participation in the MLS shall pay a one time, initial participation fee equal to: \$25 plus \$25 times the number of Subscribers at the offices at which the Participant will access the MLS. The initial participation fee is payable at the time the Participant makes application to subscribe to the MLS.

(2) Recurring Participation Fee.

The quarterly recurring participation fee of each Participant shall be an amount equal to: **\$114.00 plus \$114.00** times the number of Subscribers at the office at which the Participant will access the MLS. Payment of the recurring participation fees shall be made on or before the first day of each quarter as determined by the MLS. Except for the first recurring participation fee, no fees are prorated or refundable once paid. The first recurring participation shall be prorated on a monthly basis.

(3) Reinstatement Fee.

The Recurring Participation Fee of Participant and each Subscriber shall be due on or before the first day of each quarter. Failure to timely pay any part of the Recurring Participation Fee may result in termination of MLS access. **If MLS access is terminated, a \$100 Reinstatement Fee must be submitted prior to reinstatement of MLS access.** The Reinstatement Fee is in addition to the Recurring Participation Fee then due.

Payment Options for Texas REALTORS® MLS

We accept Visa, MasterCard and American Express. All payments are set on calendar quarters. You will be billed \$10.00 for the initial set up. Your billings will be on or about *the* 16th day of December, March, June and September. The amount billed for each calendar quarter is **\$114.00 + tax 7.52 = \$121.52.**

Your subscription will go from the date you become an active Subscriber (MLS join date) to December 31st of the first year. The 2nd year and every year thereafter, a payment of **\$432.00** will be due on January 1st for the entire calendar year.
