

TREPAC-Certified Affiliate

TREPAC recognizes Affiliate's advocacy efforts through the TREPAC Certified Affiliate program. Affiliates, like Texas REALTORS®, advocate for private property protection, promote home ownership, and participate in political awareness.

To earn TREPAC-Certified Affiliate Status, please complete the following:

- · Be an affiliate member of your local association.
- · Participate in at least two TREPAC events, annually.
- · Contribute, at least, a "Fair Share" TREPAC Investment for the year and present the importance of real estate advocacy and TREPAC* to employees twice per year.
- · At least one branch employee must sit on a state or local association Committee, TREPAC Committee, or Governmental Affairs Committee.
- Encourage all branch associates to register to vote.

*To satisfy legal requirements, make sure to provide the TREPAC solicitation disclaimer (see the bottom of this page) each time your office encourages participation in or support of TREPAC.

When these requirements have been met, contact your local TREPAC Trustee AND TREPAC Manager Zhelun Chen at zchen@texasrealtors.com to receive two coveted TREPAC distinctions that commemorate your status:

- A written declaration of your advocacy efforts to proudly display in your office.
- A TREPAC advocacy badge designed for affiliates to include in your email signatures.

Contributions are not deductible for federal income tax purposes. Contributions to the Texas REALTORS® Political Action Committee (TREPAC) and the Texas Association of REALTORS® Federal Political Action Committee (RAPC)—which makes contributions to the REALTORS® Political Action Committee (RPAC)—are voluntary and may be used for political purposes. The amount indicated is merely a guideline, and you may contribute more or less than the suggested amount. You may refuse to contribute without reprisal, and the National Association of REALTORS®, Texas REALTORS®, and its local associations will not favor or disadvantage anyone because of the amount contributed. Until the RPAC annual goal is met, 70% of an individual's contribution goes to TREPAC and may be used to support state and local candidates; the remaining 30% is sent to TAR FedPAC to support federal candidates and is charged against your limits under 52 U.S.C. 3011.6 (Exception: 100% of an individual's contribution goes to TREPAC and may be used to support state and local candidates. You may contact the Texas REALTORS®, let the RPAC annual goal is met, 100% of an individual's contribution goes to TREPAC and may be used to support state and local candidates.
